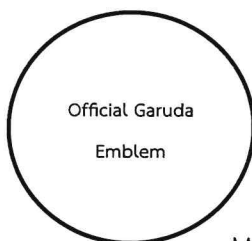

Subject: Clarification Regarding Unauthorized Claims of Exclusive Authority by Student Recruitment Agents for International Graduate Admissions

With reference to information circulating online indicating that a certain student recruitment agent has disseminated statements or promotional materials inviting prospective applicants to enroll at Rajabhat Maha Sarakham University, while falsely claiming that applications must be submitted exclusively through the agent, such actions have led to misunderstandings and may adversely affect the reputation of the University.

Rajabhat Maha Sarakham University hereby issues the following clarification:

1. The university has no policy granting exclusive authority for graduate student recruitment to any individual recruitment agent, nor has it authorized any agent to act as the sole representative for graduate student recruitment on behalf of the university.

2. Prospective applicants may submit their applications directly through official channels announced by the university, as follows:

2.1 Online through the university's Graduate School admission website:

<https://gs.rmu.ac.th/>.

2.2 In person at the Graduate School, 3<sup>rd</sup> Floor, Human Resource Development Center for Local Development (Building 41), Rajabhat Maha Sarakham University.

3. Applicants are not prohibited from proceeding through any student recruitment agent; however, they are strongly advised to exercise due diligence and interactions only with reputable and trustworthy agents.

4. Rajabhat Maha Sarakham University hereby warns that any unauthorized use of the university's name, or false claims implying special privileges or exclusive authorization, may constitute a violation of applicable laws. The University reserves the right to act in accordance with relevant regulations and legal provisions.
